# Statement about Adopting the 8th Principle

2013-2017 Background of the 8th Principle: In 2013, after many years of experience working within the UUA on Racial and Social Justice, a grassroots effort began in order to clarify the need to address "racism and other oppressions at the systemic level." This later became called "The 8th Principle Project".



Individual congregations took up the campaign and by

the 2017 General Assembly, a resolution to form an Article II Study Commission to consider the 8th principle was overwhelmingly accepted. Also in 2017, the UUUA Commission on Institutional Change was established and charged by the UUA Board of Trustees to conduct an audit of white privilege and the structure of power within Unitarian Universalism, and to analyze structural racism and white supremacy culture within the UUA. In January 2018, our congregation adopted a statement: "Our Continuing Commitment to Racial Justice," which involved not only "publicly displaying on church property a sign or banner that includes the words 'BLACK LIVES MATTER,'" but also the following 7 ongoing commitments:

communicating to the wider community in multiple ways the meaning of the sign or banner, providing ongoing, intentional learning spaces for our members, friends and the wider community to deepen understanding of systemic racism and possible ways to change it, committing to being an intentionally and proactively anti-racist congregation,

committing to raising anti-racist children, acknowledging the need to continue to reflect on our own individual and collective roles in perpetuating systemic racism, committing, as a predominantly white congregation to study and reflect on white privilege and our own complicity in institutionalized racism, and

remaining mindful of the interconnected nature of racism and other systems of oppression that impact people based on class, sex, gender identity, sexual orientation, ability, age, culture, religion, and language.

#### 2020 - Widening Circle of Concern Report and RJTPG activities converge:

In the fall of 2020, the Racial Justice Team Planning Group (RJTPG) developed a vision statement and, with the approval of the Standing Committee, initiated ongoing conversations with all the committee members at the Winchester Unitarian Society regarding its implementation. At the same time the Study/Action Guide for "Widening the Circle of Concern" (the report of the UUA Commission on Institutional Change, a three-year in-depth study of experiences of UU people of color at the Association level and in UU congregations) was released. The Study/Action Guide, a collaboration of the Commission on Institutional Change, the Liberal Religious Educators Association, Unitarian Universalist Ministers Association, and the Unitarian Universalist Association's Lifespan Faith Engagement Office, provides framing and

helpful hints on how our community can actively participate in transformative liberation.

#### 2021 and Conclusion:

Late in 2021 Rev. Dr. Susan Frederic-Gray, President of the UUA wrote in two separate essays: "We need a sea change to dismantle the deeply ingrained structures of white supremacy, exploitative capitalism, and patriarchy," and "To do the work of culture change, to live into antiracist, antioppressive, multicultural practices of the Beloved Community, we need abiding compassion, grace, and practices of solidarity and mutuality."

In light of our covenantal relationship with the wider UUA community, the Racial Justice Team Planning Group is asking members of this UU community to vote to approve the 8th principle.

We understand that:

- The duly elected members of the Social Action and Outreach Committee and the Standing Committee of the Winchester Unitarian Society have recommended that the 8th principle of Unitarian Universalism be adopted at our May, 2022 Meeting.
- The 8th Principle of Unitarian Universalism has already been adopted by more than 150 other congregations in the Unitarian Universalist Association.

We are coming to understand that:

- The 8th Principle of UU is a contemporary culmination of, not a replacement for, the 7 principles of UU, which were formally adopted by the UUA in 1985 and last modified in 1995.
- No matter what form of oppression we are working to eliminate, we need to center the voices of those who have been historically marginalized and open our hearts to a deeper understanding of the myriad of ways that we and our institutions have been complicit at the systemic level.
- There is a pressing need within our faith for "radical welcome" and ongoing cultural change for it to be relevant to future generations.

#### THEREFORE:

We, the members of the Winchester Unitarian Society adopt for the WUS, and recommend for adoption by the Unitarian Universalist Association, the following 8th Principle of Unitarian Universalism:

"We, the Winchester Unitarian Society, a member congregation of the Unitarian Universalist Association, covenant to affirm and promote: journeying toward spiritual wholeness by working to build a diverse multicultural Beloved Community by our actions that accountably dismantle racism and other oppressions in ourselves and our institutions."

## **Recruiting – July/August 2022**

The Racial Justice Team Planning Group needs and welcomes new members! It is important to have a broad representation of our congregation (age. race, gender, gender identity, etc) on this committee which has many avenues to explore as we continue the work.

The Racial Justice Team at WUS formed as an intentional group in 2016. We worked on educating ourselves through an 8- session workshop, book discussions, and community conversations. In 2018 the congregation voted to fly a Black Lives Matter flag as part of our work for racial justice. Following an on-line congregational survey, our planning group (RJTPG) began regular meetings in 2019, to continue the work.

We have been assisted by developments in the UUA, which issued a report in May 2020 addressing the structures and practices which continue to marginalize people of color. The RJTPG has held several workshops based on that report, *Widening the Circle of Concern*. This past year we worked to educate the congregation about an 8<sup>th</sup> Principle of UU.

Looking to the future, we have many avenues to explore, including offering more workshops, conducting a racial justice audit for our congregation, considering ways to live out the 8<sup>th</sup> Principle, with its focus on "actions... [to] dismantle racism and other oppressions in ourselves and our institutions."

We would like you to join us. During the pandemic the planning group has been meeting monthly on zoom, usually on a Saturday morning. We often carry out tasks in smaller groupings, so there are many ways you could be involved. A fall retreat day will be planned, with Heather facilitating, to welcome and orient new members .

We want a broader representation of the congregation and need you and your ideas. Please contact any of our continuing members to learn more details and let us know of your interest.
